The Project consists of construction of approximately 1,345,000 CY of excavation; 2,938 CY of structural fill; 684,000 SF of low permeability liner base, 684,700 SF of 60 mil HDPE geomembrane, and 668,000 SF of leachate collection layer; 2,586 LF of perforated 8-inch leachate collection pipe; 773 LF of solid 8-inch leachate pipe; 2 leachate sump station assemblies, sediment pond cleaning; 2,313 SY of all-weather access road; storm drains, and erosion and sedimentation control items.

A mandatory Pre-Proposal Conference will be held for all Proposers at 11:00 AM, local time, December 18, 2025 at the Houston County Landfill Administration Building, 2080 Highway 247 South, Kathleen, GA 31047.
