William Rape Chief Deputy County Attorney Tom Hall will conduct a second reading of an amendment to the Houston County Code of Ordinances concerning timber operations in Houston County. This is an amendment to the Houston County Code of Ordinances concerning changes to Article X – Timber Operations; Sec. 30-192 – Permit and Sec. 30-193 – Violations; penalties. The changes are being made in response to newly passed Georgia legislation that amended O.C.G.A. § 12-6-24.

The first reading of this proposed amendments to the Houston County Code of Ordinances was held at the December 1, 2020 Houston County Board of Commissioners meeting.

amendments to the Houston County Code of Ordinances Article X – Timber Operations; Sec. 30-192 – Permit and Sec. 30-193 – Violations; penalties in response to newly passed Georgia legislation that amended O.C.G.A. § 126-24. The amendments shall read as follows:

Sec. 30-192. - Permit.

(c)(6) The applicant shall be responsible for all damages and shall present a letter of credit or a cashier's check for \$5,000.00 to protect the county against damage caused by applicant. All damage exceeding \$5,000.00 shall be the responsibility of the applicant. In the event of any damage caused by the applicant then the letter of credit or cashier's check shall be subject to the provisions contained in O.C.G.A. 12-6-24 § (b)(4)(A)(B)(C) and (D).

Sec. 30-193. – Violations; penalties.

Any timber operator who shall willfully fail to comply with this article shall be guilty of a misdemeanor; amenable to the process of the Magistrate Court of Houston County, Georgia and, upon conviction, shall be punished by fine not to exceed \$1,500.00. Each day the violation continues shall constitute a separate offense.

## AMENDMENT TO CODE OF ORDINANCES HOUSTON COUNTY, GEORGIA

BE IT ORDAINED by the Board of Commissioners of Houston County as follows:

That sections 30-192(c)(6) and 30-193 of the Code of Ordinances, Houston County, Georgia, are hereby amended as follows:

#### **CHAPTER 30 – ENVIRONMENT**

#### ARTICLE X. – HOUSTON COUNTY TIMBER OPERATIONS

Sec. 30-192. - Permit.

Subsection (c)(6) shall have new language added (new language italicized for reference purposes only) and shall read as follows:

(c)(6) The applicant shall be responsible for all damages and shall present a letter of credit or a cashier's check for \$5,000.00 to protect the county against damage caused by applicant. All damage exceeding \$5,000.00 shall be the responsibility of the applicant. In the event of any damage caused by the applicant then the letter of credit or cashier's check shall be subject to the provisions contained in O.C.G.A. 12-6-24 § (b)(4)(A)(B)(C) and (D).

## Sec. 30-193. – Violations; penalties.

The amount of the fine shall be changed from \$500.00 to \$1,500.00 and shall read as follows:

Any timber operator who shall willfully fail to comply with this article shall be guilty of a misdemeanor; amenable to the process of the Magistrate Court of Houston County, Georgia and, upon conviction, shall be punished by fine not to exceed \$1,500.00. Each day the violation continues shall constitute a separate offense.

Please consider this request to accept the bid for the above referenced project. Bids were received on Friday, December 4th, 2020. Listed below is a summary of the bids:

C. W. Matthews	\$5,744,378.08
Reeves Construction	\$6,396,226.17
Robinson Paving Company	\$5,522,017.00

Based on the evaluation scores, the Engineering Department recommends the selection of **Robinson Pavement Company**, to perform the construction at the bid price of **\$5,522,017.00**. This project is to be funded by the 2012 SPLOST.

Circumstances have dictated three different change orders to the Phase II Leachate Tank Repair project at the Landfill. Change Order #1 for \$4,300 is due to the replacement of fiber board and labor; Change Order #2 for \$3,000 is for some additional sealant and labor; and Change Order #3 for \$3,500 is for the installation of five additional cathodic anodes. The original contract price of \$77,000 increases to \$87,800. The three change orders add an additional six days to the contract time.

The installation of a new 16" ductile iron water main connecting the Bear Branch Water Supply and Treatment Plant currently under construction to Frito Lay, Middle Georgia Cogen and other Bonaire/Kathleen customers is necessary. To do this we must bore under the railroad tracks near the intersection of Bear Branch Road and SR247. Georgia Southern and Florida Railway Company requires the execution of a License Agreement and payment of \$22,200. This figure includes a one-time licensing fee of \$20,300 and a \$1,900 risk management fee.

RE: Permit to cross under railroad at SR 247 and Bear Branch Road

Please consider this request to enter into a License Agreement with Georgia Southern and Florida Railway Company. The agreement will allow the Water Department to bore under and cross the railroad running parallel with SR 247 at the intersection of Bear Branch Road. This crossing will be for the installation of a new 16" ductile iron water main connecting the currently under construction Bear Branch Water Supply & Treatment Facility with Frito Lay, Middle Georgia Cogen and, ultimately, Bonaire/Kathleen.
