After a long waiting period we have finally received the completed invoice on the new custom Engines built by Rosenbauer on Bid # 23-09. This final invoice reflects several "factory" change orders and a credit adjustment for the late penalty clause in our contract. The factory change orders were made by Rosenbauer during the construction of the trucks due to items being mandatory by NFPA requirements or functionality of the truck. All change orders and final prices have been reviewed by the HCFD Apparatus Committee and found to be appropriate.

The total cost per truck after the change orders and adjustment is \$773,275.00.

For reference, the original approved price of each truck was \$777,103.00 prior to the preconstruction change orders. The final price is a cost reduction of \$3,828.00 per truck based on the originally approved price.

It is requested that these changes be approved, and Accounting make necessary changes in line-item budget to issue a check based on the attached invoices. Check will be presented to NAFECO/Rosenbauer South Dakota upon physical delivery of the completed trucks. Delivery estimate is between August 5, 2025, and August 8, 2025.

Original funding for these trucks was approved from line item 270-3500-54.2200.
