**Date:** October 28, 2025

Public Works staff solicited quotes to replace a trash compactor for the landfill. The trash compactor being replaced is a 2019 826K model with 14,826 hours and has major engine problems. This equipment acquisition requires emergency procurement due to operation of the landfill being a mission critical service not only to Houston County and its cities, but also adjoining counties. As a regional landfill, equipment such as the compactor is necessary for its continued operation.

Three quotes were received from Yancey Bros. as follows:

New Model Caterpillar 826 - \$1,196,846 Used Model 2017 Caterpillar 826K 3,950 hours- \$862,791 Used Model 2021 Caterpillar 826K 4,333 hours - \$876,571

Staff recommends the purchase of the used 826K with 4,333 hours for \$876,571 to include a trade allowance of \$108,000. Total purchase price with trade is \$768,571 to paid from landfill capital funds.
