REGISTRATION/ELECTION SUPERVISOR REPORT:

Qualifying was April 26, 2021 – April 28, 2021 for the June 15, 2021 Centerville Municipal Special Election for City Council, Post 1 (To fill the unexpired term of Cameron W. Andrew, Resigned)

Logic & Accuracy Testing on the voting equipment for the June 15, 2021 Centerville Municipal Election will start May 19, 2021 at 9:00 a.m. and continue until testing is completed.

Old Business:

Katherine Shelton briefed the Board on potential polling locations for the Year 2021- 2022. Warner Robins Recreation polling location will be moved to the Wellstone Center, 155 Maple Street, Warner Robins. The new recreational facility on N. Houston Road will be used as an additional early voting and election day location.

The Board of Elections would like physical sites used as polling locations to function for both city and county elections so voters will not be confused as to where they vote for either election; therefore,

Warner Robins municipal voters who currently vote at the Second Baptist Church will be moved to the Ted Wright polling location. Perry District two (2) municipal voters who currently vote at Rozar Park will be move to Veterans High School and Warner Robins' District four (4) municipal voters who currently vote at Feagin Mill Middle School will move to Mossy Creek Middle School.

New Business:

The Board reviewed the List of Managers & Assistant s Managers for the June 15, 2021 Centerville Municipal Special Election. A motion was made by Katherine Shelton and seconded by Henry Childs to approve the list of Managers and Assistants as printed. The motion carried.

Chairman John Applegate will serve as a representative for the Election Board on the Vote Review Panel for the June 15, 2021 Centerville Municipal Special Election.

The Board will meet on June 18, 2021 at 3:00 p.m. to review provisional/challenged ballots and certify the June 15, 2021 Special Election.

After 39 years of faithful service to the Board of Elections, Barbara Waddle announced her resignation from the Board. The Board members expressed their thanks for her service and dedication to the citizens/electors of Houston County.
