# <u>Instructions for completing your PT50-M Marine Personal Property Tax Return</u> and PT50-A Aircraft Personal Property

\*\* Note: Instructions are included with your return. These instructions are simplified and provide visual reference. \*\*

## FREQUENTLY ASKED QUESTIONS ON WHERE TO RETURN YOUR PROPERTY

- 1. All personal property of *non-residents* shall return to the county where the property is located.
- 2. All personal property of a *resident* individual shall be returned to the county where they maintain a permanent legal residence.

#### **Boats**

- □ Functionally located located in a county in this state for 184+ days during the preceding calendar year; days may or may not be consecutive.
- □ Any person who owns a boat shall return to the county where it is functionally located.
- Any person who owns a boat that does not meet the 184+ days requirement shall return to the county where the individual maintains a permanent legal residence.

#### Aircraft

- □ Primary home base where an aircraft is principally hangared or tied down and out of which its flight normally originate.
- Any person who owns an aircraft which has its primary home base in a county in this state shall return to the county in which such primary home base is located.
- □ Any person who owns an aircraft that does not have a primary home base located in another county shall return where the individual maintains a permanent legal residence.
